

Receiving a Pre-primary Education Place for Children Born in 2019

Decisions regarding pre-primary education (4 hours/day) and complementary early childhood education for children born in 2019 will be communicated to guardians **at the end of January or beginning of February** via eDaisy. Guardians will also receive an email notification about the decisions.

After receiving the decisions, the guardian must either accept or reject them in eDaisy within two weeks. If you have no access to eDaisy you can inform your acceptance/rejection by email to (varhaiskasvatus.palveluohjaus@hyvinkaa.fi). The guardian can choose from the following options:

A. Accepting the Decisions

If the guardian selects "**Accept preschool and complementary early childhood education**" the processing of the decisions is complete, and the pre-primary education place is confirmed.

If the guardian selects "**Accept only preschool**," the complementary early childhood education is entirely canceled. If necessary, the guardian can later apply for complementary early childhood education again in eDaisy.

B. Accepting the Decisions and Changing the Hour Limit for Complementary Early Childhood Education

The hour limit stated in the decision for all students for complementary early childhood education is 106–146 hours/month. The guardian can change the hour limit if desired.

If the guardian selects "**Accept preschool, change complementary early childhood education**," the hour limit for complementary early childhood education can be changed. The guardian must select the desired new hour limit from the dropdown menu. Note: Pre-primary education hours (4 hours/day) are not counted in the complementary early childhood education hours. After this, the guardian will receive a new decision in eDaisy.

C. Rejecting the Decisions

The guardian can reject the decisions if the child does not need a pre-primary education place at all.

The guardian can also reject the decisions and apply for a secondary pre-primary education place in eDaisy by filling out a new pre-primary education application. The secondary pre-primary education place must be applied for within two weeks of receiving the first decision.

If applying for a secondary pre-primary education place at Metsäkalteva, Nopo, Ridasjärvi, or Kytäjä schools or Talvisilta teaching unit, the guardian must contact basic education at perusopetus@hyvinkaa.fi.

When applying to a municipal daycare center, complementary early childhood education can be applied for simultaneously in eDaisy. In private daycare centers, complementary early childhood education is provided with a service voucher. To receive the service voucher, the guardian must contact the private daycare center director to arrange for complementary early childhood education. In pre-primary education organized by basic education, complementary morning and afternoon activities are offered, which can be applied for at the following link:

A secondary pre-primary education place can be granted if there is space in the pre-primary education group. The guardian should note that a secondary pre-primary education place does not entitle the child to transportation benefits.
